PRIVACY POLICY

The controllers will process data by using electronic or automatic means and non-automatic means (paper records), both provided with appropriate security measures. The data will be processed only by staff members previously and specifically authorized by the Data Controllers. Without prejudice to the communications provided to comply with law obligations, the Data Controllers will communicate the provided personal data only to third parties specifically appointed and designated for the purpose of providing commercial, administrative, fiscal, and legal support or subjects belonging to the category of providers of Internet or IT services, conveniently designated as Data Processors.
